Many Adagio training options

Windows Vista Update

We are still receiving many inquiries regarding Adagio and its compatibility with Windows Vista. Current Adagio modules WILL NOT install under Vista. While it is possible to install the Adagio modules under Vista by completely disabling User Account Control, once the modules have been installed, the following known issues (amongst others) will be encountered:

- Faxing of documents will not work
- F1 Help will be unavailable

All modules require updating to Version 8.1A, which Softrak is currently working on.

Softrak is fully committed to compatibility with Windows Vista for all Adagio products. New versions of all currently shipping Adagio products will be released for compatibility with Vista. Compatibility upgrades for Adagio products will begin releasing in the second quarter of 2007. It may be several months before all compatibility releases have been completed for the entire product line. Expect the core Adagio modules to be released first.

The best and most economical way to prepare your Adagio for Vista is by making sure you are on the Adagio Upgrades Plan. This will ensure you are the first to receive the upgrades as soon as they become available. When these 8.1 versions are released, any client who is not on an Upgrades Plan must purchase at the Prior Version price, which is more expensive. Act now and save!

Changing Sales Tax Rates

Here is a brief summary of what must be done in some Adagio modules to change a sales tax rate. A complete, step-by-step procedure guide for all modules is available in the Technical Tips page of Softrak's website, at www.softrak.com, under the Support heading. You can also download a spreadsheet to calculate Tax Included distribution rates there as well.

Adagio OrderEntry

- Run dayend
- Print and purge the Tax Summary report
- Edit the tax groups
 - Select the tax group to be edited
 - Select the jurisdiction
 - Change the tax rate

Adagio Invoices

- Post or archive all invoice batches
- Print and purge the Tax Summary report
- Edit the tax table: Item & Customer rates
 - Select the tax group to be edited

- Select the jurisdiction
- Change the tax rate

- Update Archive Batches and select the item tax fields to update
- Restore the archive batches

Adagio Inventory

- Run dayend
- Print and purge the Tax Summary & Tax Tracking reports
- Edit the tax groups: Item and Purchase Tax Rates
 - Select the tax group to be edited
 - Select the jurisdiction
 - Change the tax rate

Adagio Payables

- Print and clear the tax tracking report (recommended but not required)
- Edit the Distributions to change the tax rate for Tax or Tax included Distributions
- After changing the tax rates
 - Restore all recurring batches
 - Edit all details that reference tax or tax included distributions
 - Archive the updated recurring batches
 - Edit all Distribution Sets to refresh all the tax rates for Tax or Tax included Distributions (re-select Distribution to refresh)

Adagio Receivables

- Print and clear the tax tracking report (recommended but not required)
- Edit the Distributions to change the tax rate for Tax or Tax included Distributions

Adagio Checks

- Edit the Distributions to change the tax rate for Tax or Tax included Distributions
- Edit the archive batches to refresh the tax rates that reference tax or tax included distributions
- Refresh the rate by removing and re-selecting the distribution code from the finder.
